Per GMC 5.04.180- Every person having a license issued pursuant to the provisions of this chapter and commencing or conducting the business mentioned in the license at a fixed place of business shall keep such license conspicuously posted and exhibited in such place of business while the license is in force. Every person having such a license and not having a fixed place of business shall carry or transport such license with him at all times while conducting such business.

**OTHER IMPORTANT INFORMATION**

**Business License does not permit business otherwise prohibited.** The payment of a business license fee required by the provisions of the Gardena Municipal Code and its acceptance by the city and the issuance of a business license to any person shall not entitle the holder(s) thereof to carry on any business unless he/she/they has complied with all the requirements of said code and all other applicable laws, nor to carry on any business in any building or an any premises designated in such a business license in the event such building or premises are situated in a zone, or locally in which the conduct of such business is a violation of any law. This license is issued without verification that the licensee(s) are subject to or exempt from licensing by the State of California.

**RENEWAL INFORMATION**

For your convenience, the City of Gardena offers residents and businesses the option to renew their business license via the Internet. All you need to access this service is your business license account number and security code. This information is pre-printed on your business license renewal notice in the upper right-hand corner. NOTE: If you do not have the original letter mailed out with your security code and account number, please contact the City of Gardena to obtain a reprint of your renewal notice.

It is the license holder's responsibility to renew their license each year to avoid any fines or penalties. Penalties will be assessed if the license is not renewed by the renewal due date .
